



Thank you for booking a site at the GSS Car Boot Sale!

Please read the below terms and conditions

Entry to sites is between 7-7:45am only and must be ready to trade from 8am-12pm. Packing up cannot begin until 30mins prior to scheduled market closing time and no vehicles may move or leave the site until the markets are closed at 12pm. All stalls must be packed up and removed from site by 2pm.

The allocation of market sites is on the day of the event and is at the discretion of authorized P&C Members and volunteers. Ownership, possession and control of sites is held by Griffin State School at all times. GSS P&C authorised staff & volunteers reserve the right to refuse entry to any person into the market at their sole discretion. All stallholders shall comply with reasonable directives by GSS P&C authorized staff, members and volunteers during the event and setup/packup times.

No power is available for stallholders.

The event is designed for 2nd hand goods sales by private stallholders and is not for commercial market stall businesses.

Stallholders are to ensure that their site is always attended, presentable, professional and safe and all displays are contained within the set site parameters. All goods being sold must be deemed acceptable by the GSS P & C Organizers and must comply with the local Council regulations. No hazardous or offensive goods (including weapons) are permitted to be sold. Alcohol, tobacco products and smoking utensils are not to be displayed or sold. No pirated goods e.g. DVDs, clothing, or CDs are allowed to be sold. No birds or animals may be sold

The GSS P&C reserve the right to sell all food and cold drinks as a school fundraiser, therefore no food or drinks are to be sold.

Stallholders must leave their site in a clean state and all waste must be removed from the site upon leaving.

Stallholders are responsible for supplying their own vehicle, tents, tables, chairs etc. Do not purchase these items until your application has been accepted. Organizers accept no responsibility for damage or loss by participating Stallholders.

Stallholders are required to attend their site in all weather conditions and only GSS P&C authorized staff can announce a cancellation of the market should the weather conditions become unsafe. Should the event be officially cancelled, all stalls fees will be refunded. However, should a stallholder choose not to attend the event without official cancellation by the organizers, no refunds will be given. Should you need to cancel your stall prior to event, the cut off for this is 1 week prior at 5pm 16th July. Cancellation after this date, will result in no refund being given. Any cancellations must be received in writing to pandc@grifnss.eq.edu.au

No smoking or dogs (except guide dogs) are permitted within school grounds.

In case of an emergency, stallholders are to comply with GSS P&C authorized staff, members and/or volunteer directions and proceed to the designated assembly area located in the top carpark outside school admin building.

Organizers reserve the right to change the times and dates of the market without notice.
